



TRADE WITH MEDIRECT AND WIN  
TERMS AND CONDITIONS

Participants agree to be bound by these Terms and Conditions and all other special conditions relating to the "Trade with MeDirect and Win" competition ("The Competition").

1. The promoter is MeDirect Bank (Malta) plc ("The Promoter"), whose registered office is: The Centre, Tigne Point, Sliema, TPO 0001, Malta.
2. To be eligible to enter the competition, the eligible participant ("The Participant") must:
  - I. be a real person, aged 18 years or older, residing in Malta and not an employee of the Promoter;
  - II. has successfully completed an application to become a MeDirect customer;
  - III. buy any investment security using the MeDirect trading platform for a minimum of €100.
3. In particular and without prejudice to the generality of the foregoing, only investment securities which are operationally supported by the Bank's platform may be purchased. If a customer wishes to invest in a security that is not on the Bank's platform, the Bank will check whether the security can be added onto the platform.
4. The financial instruments linked to this promotion may not be suitable for all customer(s). Unless otherwise specified, customer(s) alone are solely responsible for determining whether any investment, security or strategy or any other product or service, is appropriate or suitable for them based on his/ her investment objectives and personal and financial situation. The customer(s)'s decision to buy any investment security using the MeDirect trading platform shall not be linked or determined by the possibility to win the Competition prize.
5. New and existing customers who meet the criteria outlined in Section 2 shall be automatically deemed to be Participants and will be eligible to participate in this Competition. Every security bought will give each Participant the opportunity to win the following prizes:

    - On the 7<sup>th</sup> of January 2022 (drawn from all successful buy trades done between the 1st and the 31st of December 2021)
    - On the 7<sup>th</sup> of February 2022 (drawn from all successful buy trades done between the 1st and the 31st of January 2022)
    - On the 7<sup>th</sup> of March 2022 (drawn from all successful buy trades done between the 1st and the 28<sup>th</sup> of February 2022)
  - A voucher of €250 from The Point Shopping Mall which will be drawn every week on a Monday covering all successful buy trades done in the previous week:

11. The winner has the right to decline the prize, and, in such instances, the Promoter reserves the right to withdraw the prize from the winner and pick a replacement winner.
12. The Promoter will notify the winner when the prize can be collected from the Promoter's registered office noted in clause 1 above.
13. We reserve the right to request proof of a prize winner's identity in the form of an ID Card, passport or driver's licence. In the event that a prize winner cannot provide us with proof of identity that is reasonably acceptable to us, we may withdraw the prize and select another prize winner.
